- 8. Several members expressed their appreciation to Beal Traister or his many years of service as BWCC Trustee.
- 9. John Kremmerer and Dennis Strohmeyer are working on an event for Saturday, November 9<sup>th</sup> from 12:00 to 2:00 for new Probationary Members and any Fulltime Members that would like to attend. John and Dennis have volunteered to be the primary contact for new members to help them get acquainted with Club facilities, rules, events and membership activities and opportunities. They are looking for a few Fulltime Members to help with events and range access for the orientation events.
- 10. Rocky has begun collecting Membership dues for 2025. He will collect them through the beginning of the March 2025 Membership Meeting. They can also be paid for at meetings or any of our regular public shoots.

- 11. Only 23 people have responded to the **Wednesday Skeet Survey** sent out by Vicky. It has not provided any solutions for the sign-up process or the wait time experienced by shooters. Vicky will send it out again in the Spring and continue to discuss it with Members.
- 12. Effective January 1, 2025, the price for soft drinks will be raised to \$1.25 and the price for candy will be raised to \$1.50 to help offset the Club's cost for these items. Currently we are losing money on both.
- 13. The December meeting will be held on Thursday, December 12<sup>th</sup>. The annual Christmas potluck will be held before the December Membership Meeting at 6:00pm. This change is due to the hunting season as a lot of members will be hunting. There will be no Trap Event on December 12<sup>th</sup>. Bring any food to share if you want to and mingle with members
- 14. Water service for the Club was discussed again. It seems most members want water service on site, and they are asking why the Club has not moved forward with it. Some are questioning why we are holding on to funds rather than implementing requested improvements. They asked how much money the Club needs to have in reserve and what is the basis for this amount. We will ask the Trustees to to address this concern at the next Trustee Meeting.
- 15. **Members who are active on social media** are encouraged to share information about the Club and the Club events to help increase awareness and participation in the Club's Programs.
- 16. **Close of Meeting**: There being no other business, a motion was duly made, seconded, and passed to adjourn the meeting at 8:27 PM.
